NOTIFICATION

- Ref:-** 1) High Court's Notification No. 3/2023 dt 11-01-2023, inviting applications for direct recruitment to the posts of Computer Operator in the service of the High Court for the State of Telangana.
- 2) High Court's Notification No. 3/2023, dated 12-01-2024, declaring the hall ticket numbers of the candidates shortlisted for certificate verification.
- 3) High Court's Notification R.O.C. No. 113/2023, dated 12-01-2024, informing the date, time and venue of original certificates verification.

It is to inform that, the High Court declared the hall ticket numbers of the candidates who have been shortlisted for certificate verification vide notification 2nd cited, in connection with the direct recruitment to the posts of **Computer Operator** in the Telangana High Court Service under Notification No. 3/2023 dated 11-01-2023.


