The Junior Civil Judge (Juvenile Court)-cum-Judicial Magistrate of First Class, Adilabad, who is placed as full additional charge of the post of Junior Civil Judge, Utnoor, Adilabad District, shall conduct the Court proceedings at Utnoor itself atleast once in a week as per the circular instructions in ROC.No.5523/WRC, dated 25.11.2003, under intimation to the High Court for information.
