

**PROCEEDINGS OF THE HIGH COURT FOR THE STATE

Sub:- Public Services – TJMSS – Carving out 33 Judicial Districts in the State of Telangana co-terminus with Revenue Districts – Tentative allocation of employees working in the erstwhile District of **Nalgonda** to the newly carved out Districts namely **Nalgonda, Suryapet and Yadadri-Bhongir** Districts – Objections called for and received – Considered the objections – Final allocation of the employees to the newly carved out Judicial Districts – **Orders - Issued.**

ORDER ROC.No.864/2022-C.1, DATED: 26-10-2022.

Pursuant to the carving out of 33 Revenue Districts by the State Government, the High Court has decided to carve out 32 Judicial Districts from the erstwhile 9 Judicial districts (except Hyderabad) co-terminus with Revenue districts. Accordingly, necessary notifications were issued by the Government carving out the newly formed Judicial Districts and started functioning w.e.f., 02.06.2022.

The Hon'ble the Chief Justice has been pleased to constitute a committee of Hon'ble Judges for framing of guidelines and final allocation of employees in consultation with the Government as per Para 4 of Presidential Order dated: 29.08.2018, vide G.O.3rd read above.

As per the guidelines issued vide reference 4th read above, the members of Telangana Judicial Ministerial and Subordinate Services were directed to submit their options to the erstwhile Unit Head/Principal District Judge concerned for onward transmission to the High Court for their allocation. Accordingly, on

considering the options received, the Committee of Hon'ble Judges has allocated the employees tentatively and the same was published by the Registry (under reference 5th read above) with a request to submit their objections, if any, for the tentative allocation and shall forward their objection / representation to the High Court on or before **28.09.2022** in a sealed cover.

Accordingly, on considering the objections/representations received against the tentative allotment, the Committee of the Hon'ble Judges authorized by the Government, has made the following final allotment orders in view of the guidelines and availability of vacancies as per Annexure appended here to.

The allotment of the promoted employees of the Unit of the erstwhile Nalgonda district (51 employees who are promoted after the due date of promotion process as per directions of the High Court) were ratified and allotted keeping in view of the declaration given by the said employees and availability of vacancies in the promoted category.

The District Judges, **Nalgonda, Suryapet, Yadadri-Bhongir** are hereby directed to relieve the allotted employees with whom they are working so as to enable them to join in the newly allotted District and the District Judges concerned shall issue posting orders to the employees who are allotted to their units. The relieving and joining dates of the employees shall be as under.
