THE HON'BLE THE CHIEF JUSTICE ALOK ARADHE <u>AND</u> THE HON'BLE SRI JUSTICE J.SREENIVAS RAO

WRIT APPEAL No. 1247 of 2024

ORDER: (Per the Hon'ble the Chief Justice Alok Aradhe)

Mr. G.Veera Babu, learned counsel for the appellants.

Ms. S.Swathi, learned Assistant Government Pleader for Irrigation and Command Area Development Department for the respondents No.1 to 3.

Mr. Muralidhar Reddy Katram, learned Government Pleader for Revenue for the respondent No.4.

Mr. Mahesh Raje, learned Government Pleader for Home for the respondents No.5 to 7.

2. With the consent of the learned counsel for the parties the matter is heard finally.

3. This intra court appeal is filed against the order dated 14.10.2024 by which the writ petition preferred by the appellants i.e., W.P.No.17432 of 2024 has been dismissed.

Facts giving rise to filing of the appeal briefly stated 4. are that the appellants claim to be landless poor persons and have constructed small huts in Stalin Nagar Colony on the outskirts of Paidipally Village, near the Sri Ram Sagar Project Canal, Warangal, admittedly on the Government land. The respondents initiated action for their dispossession. Thereupon, the appellants filed the writ petition in which the action of the respondents in interfering with the possession and enjoyment of the appellants' premises, was assailed inter alia, on the ground that the same is illegal and arbitrary. The learned Single Judge, by an order dated 14.10.2024, has dismissed the writ petition. Hence this appeal.

5. Learned counsel for the appellants submits that the appellants have encroached the Government land as they are landless poor persons. It is further submitted that the appellants are entitled to the benefit of the housing scheme framed by the State Government. It is further submitted that the appellants be granted reasonable time to vacate the premises in their occupation.

6. On the other hand, the learned Government Pleader for Revenue has submitted that in case the appellants furnish an undertaking before the respondent No.3 -Executive Engineer, the appellants shall be permitted to occupy the premises for a period of four weeks. It is further submitted that in case the appellants fail to vacate the premises, the respondents be granted the liberty to take action for their eviction. It is also submitted that in case the appellants submit an application for allotment of the houses under the scheme, the same shall be considered in accordance with law.

7. In view of the aforesaid submissions and in the facts and circumstances of the case, it is directed as under:

i) In case the appellants furnish an undertaking before the respondent No.3 - Executive Engineer, by 02.11.2024 that they shall vacate the premises in their occupation peacefully on or before 01.12.2024, action for demolition of the houses of the appellants shall not be taken;

ii) In case the appellants fail to file the aforesaid undertaking, the respondents shall be at liberty to

take an action against the appellants for their dispossession in accordance with law;

In case the appellants submit an application iii) seeking the benefit of the housing scheme framed by the State Government, such application shall be duly processed by the respondent No.4 - District Collector.

To the aforesaid extent, the order passed by the 8. learned Single Judge in W.P.No.17432 of 2024 is modified. It is made clear that this Court has not expressed any opinion on the merits of the matter.

The appeal is accordingly disposed of. 9.

Miscellaneous applications pending, if any, shall stand closed. However, there shall be no order as to costs.
