On the recommendation made by the High Court, 33 candidates i.e., 28 candidates by direct recruitment and 5 candidates recruitment by transfer to the post of Junior Civil Judges were appointed by the respective Governments of Telangana and Andhra Pradesh vide G.O.Ms.No.64, Law (L.A & J - Home Court.A) Department, dated 09.09.2016 Government of Telangana, Hyderabad and G.O.Ms.No.106, Home (Courts.A) Department, dated 20.09.2016, respectively (copy enclosed) and issued orders creation of 33 supernumerary posts of Junior Civil Judges in the scale of pay of Rs.27700-770-33090-920-40450-1080-44770/- of Judicial Pay Scales with usual allowances payable at Andhra Pradesh Judicial Academy, Secunderabad for a period of 3 months from the date of commencement of training for those officers selected pursuant to the recruitment undertaken for the year 2015, by authorizing the Director, Andhra Pradesh Judicial Academy, Secunderabad, to draw and pay the pay and allowances for the said officers during their training period, treating such training period as on duty for all purposes, by the respective Governments, vide G.Os. 5th and 6th cited (copy enclosed)

As per Rule 8 of Andhra Pradesh State Judicial Service Rules, 2007, every person who is appointed to the category of Civil Judges shall under go training for a period one year. While so, the High Court has been pleased to resolve to direct all the 33 candidates i.e., 28 candidates appointed by direct recruitment and 5 candidates appointed recruitment by transfer to the post of Junior Civil Judges by the respective State Governments of Telangana and Andhra Pradesh to under go basic training for a period of 3 months from 05.01.2017 onwards.

In view of the above, the High Court is pleased to pass the following order:

All the 33 newly selected Junior Civil Judges referred in the Annexure – I, are hereby directed to report before the Director, Andhra Pradesh Judicial Academy, S.P. Road, Secunderabad at 8.00 a.m. on 05.01.2017 for undergoing Basic Training for a period of three months from 05.01.2017 onwards.

The officers are further directed to submit Medical Fitness Certificate obtained from a Doctor not below the rank of Government Civil Surgeon and submit the same to the Director, Andhra Pradesh Judicial Academy, Secunderabad, while reporting to training.

The trainee Junior Civil Judges will be under the control of the Director, Andhra Pradesh Judicial Academy, Secunderabad during the period of their training.

At the end of three months training, the Director should submit the report to the High Court with reference to each trainee officer regarding successful completion of 3 months basic training.

The Director will collect the Statement of Properties and Relations in respect of 33 Candidates and send the same to the High Court.
