**NOTIFICATION**

- REF:-1)** High Court's Notification Nos.01/2019 to 08/2019, dated 31-07-2019 issued inviting applications for recruitment to the posts under direct recruitment in the Telangana Judicial Ministerial and Subordinate Service.
- 2)** High Court's Notification dated 09-10-2020, declaring the hall ticket numbers of the provisionally selected candidates for the posts of Stenographer Grade – III, Typist and Copyist.
- 3)** High Court's Notification dated 31-10-2020 declaring the hall ticket numbers of the provisionally selected candidates for the posts of Junior Assistant, Field Assistant, Examiner, Record Assistant and Process Server.

It is hereby informed that the High Court for the State of Telangana has issued Notification Nos.1/2019 to 8/2019, dated 31-07-2019, inviting applications through online for direct recruitment to the posts of 1)Stenographer Grade – III, 2)Junior Assistant, 3)Typist, 4)Field Assistant, 5)Examiner, 6)Copyist, 7)Record Assistant and 8)Process Server respectively, under the Telangana Judicial Ministerial and Subordinate Service, and the candidates were subjected to the computer based examination and skill test (for technical category posts) and viva-voce (oral interview).

The High Court vide references 2<sup>nd</sup> and 3<sup>rd</sup> cited, declared the hall ticket numbers of the provisionally selected candidates for technical category of posts and non-technical category of posts respectively and uploaded in the website of the High Court on 09-10-2020 and 31-10-2020 respectively.

Subsequently, during the course of verification of the educational, technical, certificates in proof of prescribed qualifications i.e., date of birth, local and non-local status, it is noticed that some of the provisionally selected candidates are not having requisite qualifications, some of them are not within the prescribed age and some of them though claimed themselves as local candidates, they are not local candidates as per the certificates. On noticing such discrepancies in the

provisional selection of candidates, the High Court decided to **cancel the provisional selection of such candidates, who are ineligible as per the recruitment Notification.** The hall ticket numbers of such candidates, whose provisional selection is cancelled are shown at **Annexure - I.**

In place of the candidates whose provisional selection has been cancelled, the High Court has selected candidates, who are having all the requisite qualifications as per the recruitment Notification.

The hall ticket numbers of the **newly selected candidates** in place of candidates whose provisional selection is cancelled, are shown at **Annexure - II.**
