NOTIFICATION

Ref:- High Court's Notification No. 6/2023 dt 11- 01-2023, inviting applications for direct recruitment to the posts of Assistant in the service of the High Court for the State of Telangana.

It is to inform that, the High Court declared the hall ticket numbers of the qualified candidates who have been shortlisted for certificate verification vide notification dated 09-10-2023 to the posts of **Assistant** in the Telangana High Court Service by direct recruitment under Notification No. 6/2023 dated 11-01-2023.

It is further to inform that, the High Court conducted certificate verification on 12-10-2023 and approved the list of eligible candidates to attend the oral interview as shown in Annexure appended to this notification.

- Note : 1) The Candidates have to bring hall ticket of the written examination, along with the call letter of the oral interview, and also the requisite original certificates on the day of oral interview.
- 2) The candidates who have not submitted any of the required certificates on the day of certificate verification, are instructed to bring the same (original and 2 copies attested by the Gazetted officer) on the day of oral interview without fail, otherwise they will not be permitted to attend for oral interview.
