- Sub: High Court for the State of Telangana Continuing the present practice of Virtual hearing of cases by all the Benches in the High Court till 08.08.2021 and taking up physical/virtual hearing of cases by the Division Benches and Single Benches on turn basis from 09.08.2021 to 09.09.2021 as per the schedule annexed Instructions Issued.

Considering the current unlock down situation in the State and the views of the learned members of the Bar, it is decided to continue the present practice of virtual hearing of the cases till 08.08.2021 and thereafter to take up physical as well as virtual hearing of the cases by the Division Benches and Single Benches on an experimental basis from 09.08.2021 to 09.09.2021 as per the schedule annexed herewith. Accordingly, as directed, the following instructions are issued to all the stake holders:

- 1. During the course of physical hearing, learned Advocates/ Parties-in-person should adhere to the COVID-19 protocols, they shall wear face mask/cover, using of sanitizers and keep physical distancing etc.
- 2. Only those learned Advocates/Parties-in-person shall be allowed to enter into the High Court premises whose cases are listed and for that, they shall show the listing of the case(s) either on mobile or by other mode.
- 3. The Learned Advocates/Parties-in-person who are vaccinated only will be permitted to enter into the premises of the High Court and for that, they shall keep the vaccination certificate with them to be shown at the time of entry into the premises without any protest, otherwise, the High Court may withdraw arrangement for physical hearing of the cases. Relaxation shall be given only to those persons whose vaccination cannot be done for medical reasons as per the advisory of the Central/State Government.
- 4. During the physical hearing of cases also, the learned Advocates/ Parties-in-person are permitted to opt for virtual hearing with advance information to the Registry.
- 5. All other instructions notified in the "Standard Operating Procedure for physical/virtual hearing of cases before the Hon'ble High Court" in ROC No.394/SO/2020 dated 18.02.2021 with latest schedule shall continue to be in force till further orders.
